PROOF OF FAIRFAX COUNTY RESIDENCY MUST BE CLEAR, CURRENT, AND DISPLAYED ON 8.5 X 11 PAPER.

Fairfax County Proof of Residency

Fairfax County will conduct random roster audits, for which valid proofs of residency must be promptly provided. To be ready for such an audit, team reps should maintain a complete set of proofs for their team. A valid proof may be a copy of any current driver's license or DMW identification, active military identification, or voter registration card. The proof should be clear and legible, the date should be current, and the name and address should match that on the registration form.

FWSA Refund Policy

Prior to the first schedule game, refunds may be given for any reason and will include late and/or out-of county fees. The deadline for requesting a refund will be the day before the first game of the originally published schedule. Requests must be in writing to the appropriate Division Commissioner and post-marked by the deadline. Written requests may also be hand carried to the Commissioner on the deadline day. No partial refunds will be given.
